INSTALLATION INSTRUCTIONS

- Raise vehicle allowing the axle to hang freely.
- Remove existing bump stop assembly using 10mm socket.
- Mount Timbren assembly to existing bump stop bracket using Timbren supplied fasteners.
- Lower vehicle.

NOTES:

Use LOCK NUT (Item #1) if vehicle is older than 1992.

INSTRUCTIONS DE MONTAGE

- Soulever le véhicule de sorte que l'essieu soit dégagé.
- Retirer la butée de suspension existante avec un clef à tube de 10mm.
- Monter l'assemblage Timbren au support de la butée de suspension existante en utilisant la boulonnerie fournie avec l'assemblage Timbren.
- Redescendre le véhicule.

REMARQUES:

Utiliser un CONTRE-ÉCROU (article no1) si le véhicule a été fabriqué avant 1992.

INSTRUCCIONES DE INSTALACIÓN

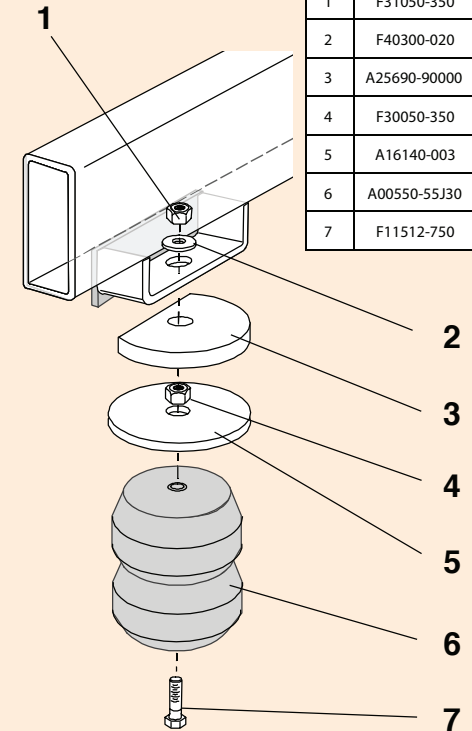
- Levante el vehículo dejando que los ejes cuelguen libremente.
- Retire el tope de suspensión existente con una llave de cubo de 10mm.
- Monte la unidad Timbren a la abrazadera de tope de suspensión utilizando los elementos de sujeción Timbren provistos.
- Baje el vehículo.

NOTAS:

Utilice TUERCA DE SEGURIDAD (ítem #1) y el vehículo es un modelo anterior a 1992.
